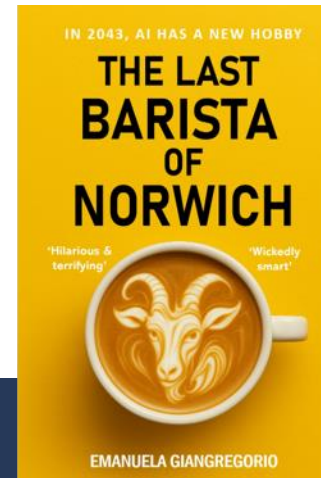
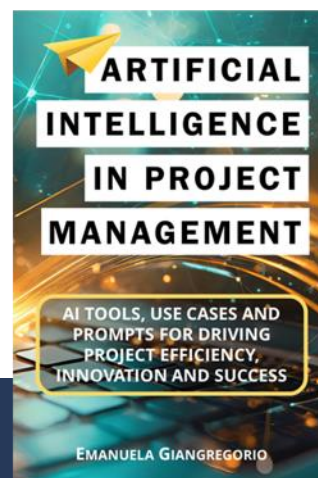
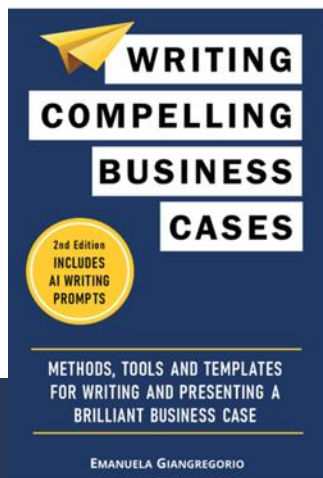

Why is a Governance Framework needed for AI-Assisted projects?

- **Projects** are the **PRIMARY** mechanism for operationalising an organisation's strategy, and **Project Management** remains one of the few **skills relevant to MOST** business professionals (more than 70%).
- **AI adoption in projects is increasing exponentially**, with little to no governance.
- **Governance** of how **AI** is used in **projects** is getting more attention and will soon be a **board-level mandated requirement**.
- **Before AIPGF, NO guidance** on HOW TO PRACTICALLY implement AI governance in projects.

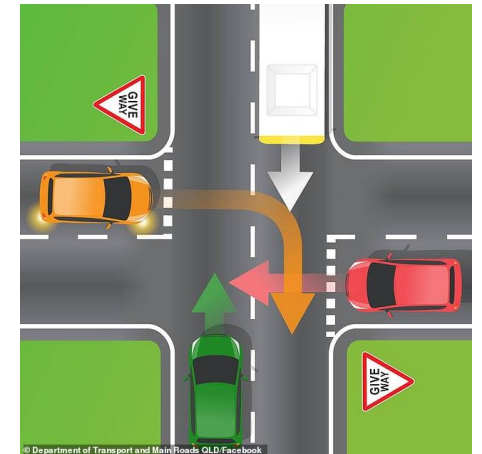
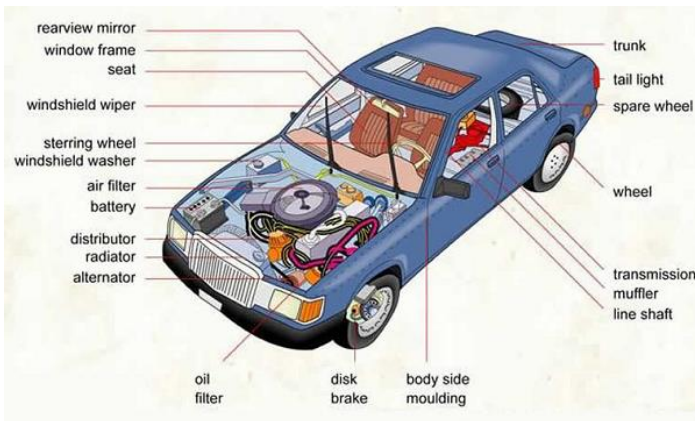


ISO24k v AIPGF v AI PM Training?



ISO24k is like a global best practice standard providing rules for any means of transportation.

The **AIPGF** teaches you the traffic laws and road safety specifically for driving cars (any type of car), ensuring safe and responsible driving.



AI PM training: Learning how to use AI tools in projects is like learning how to operate specific types of cars. With AI, the tools are constantly changing, difficult to keep courses up to date.

Why is a Governance Framework needed for AI-Assisted projects?



Increasing regulations like **EU AI Act** and **ISO standards** driving demand for structured AI governance. **AIPGF** shows practically “**how to**” in project environments.



Evidence of AI governance in project management will be a **competitive differentiator** (talent attraction, stakeholder trust, personal career advancement).



Organisations are already hiring hybrid roles that **combine AI governance** with **project management**.

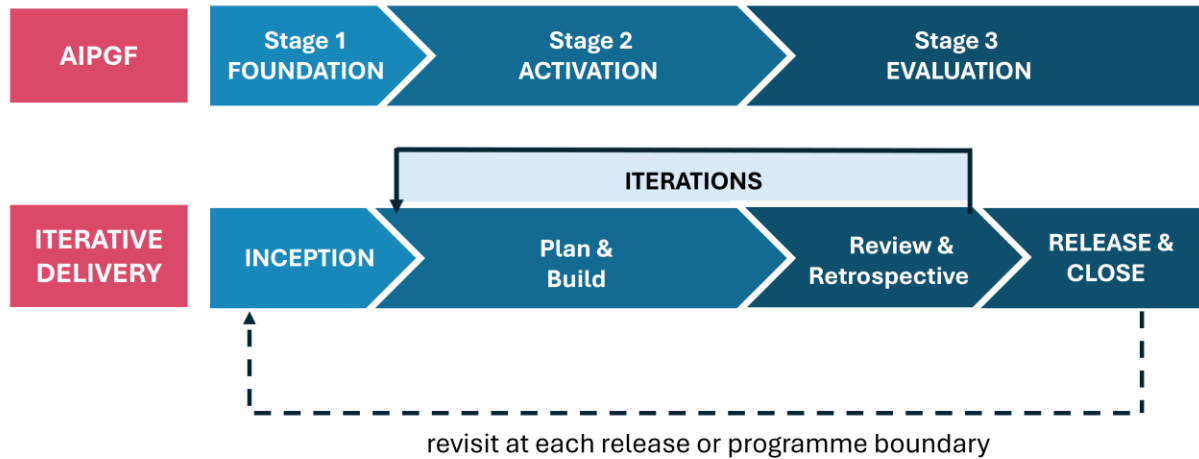

Easily integrates with existing project management approc or approaches, such as **Agile**, **PRINCE2**, **PMBOK** or hybrid approaches.

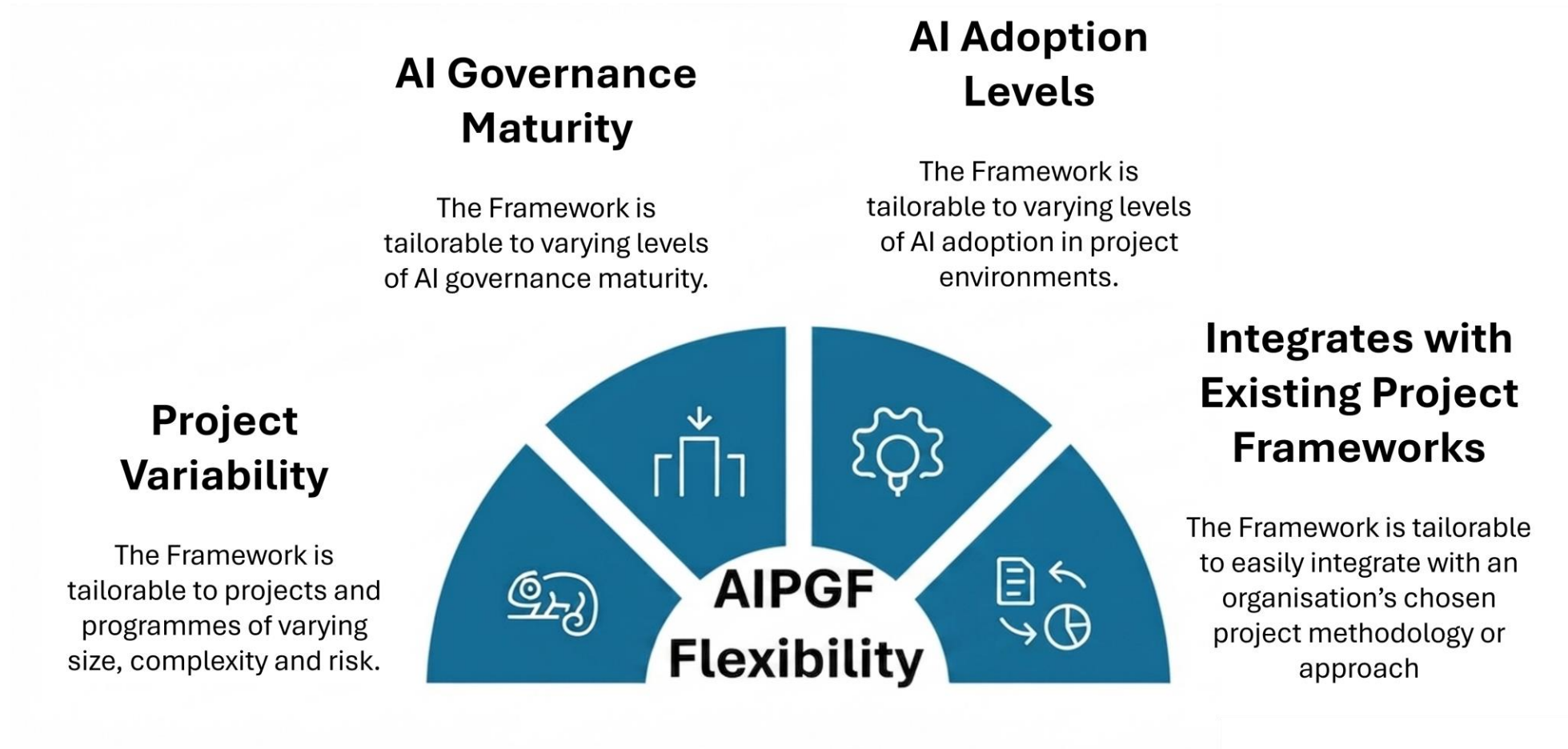
Iterative Delivery Mapped to AIPGF



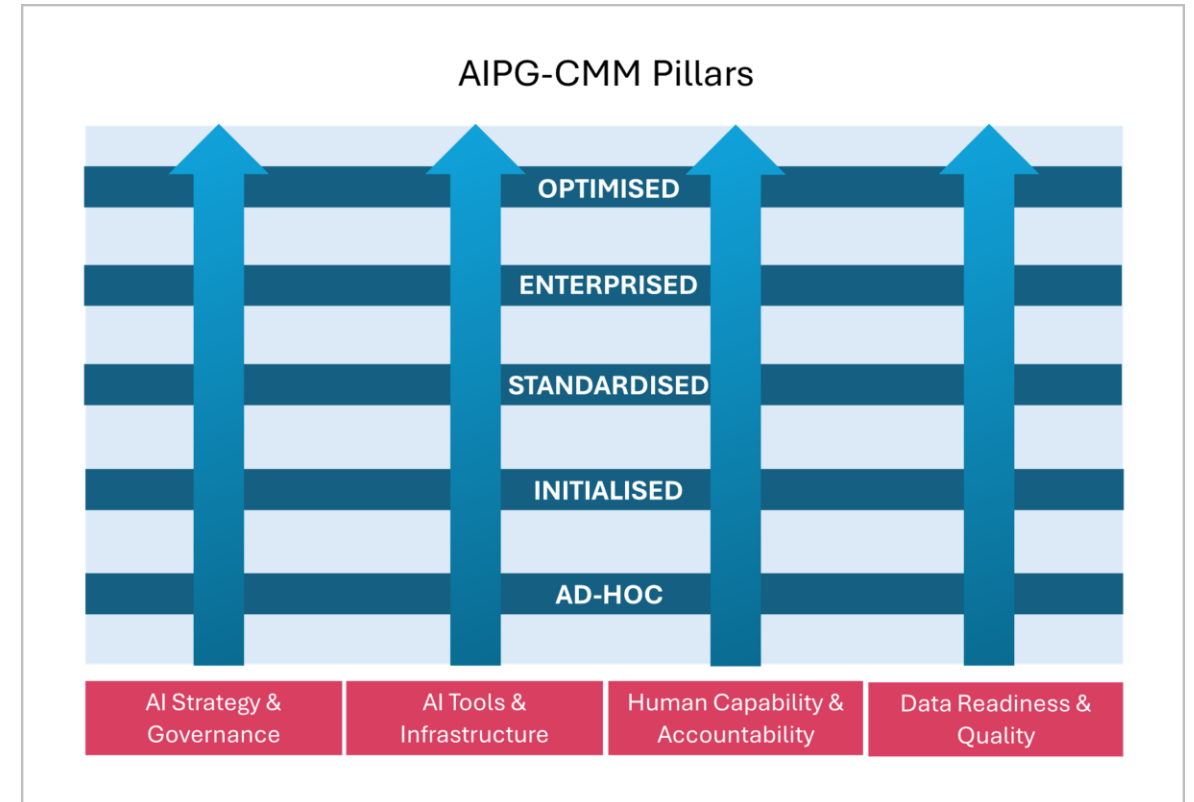
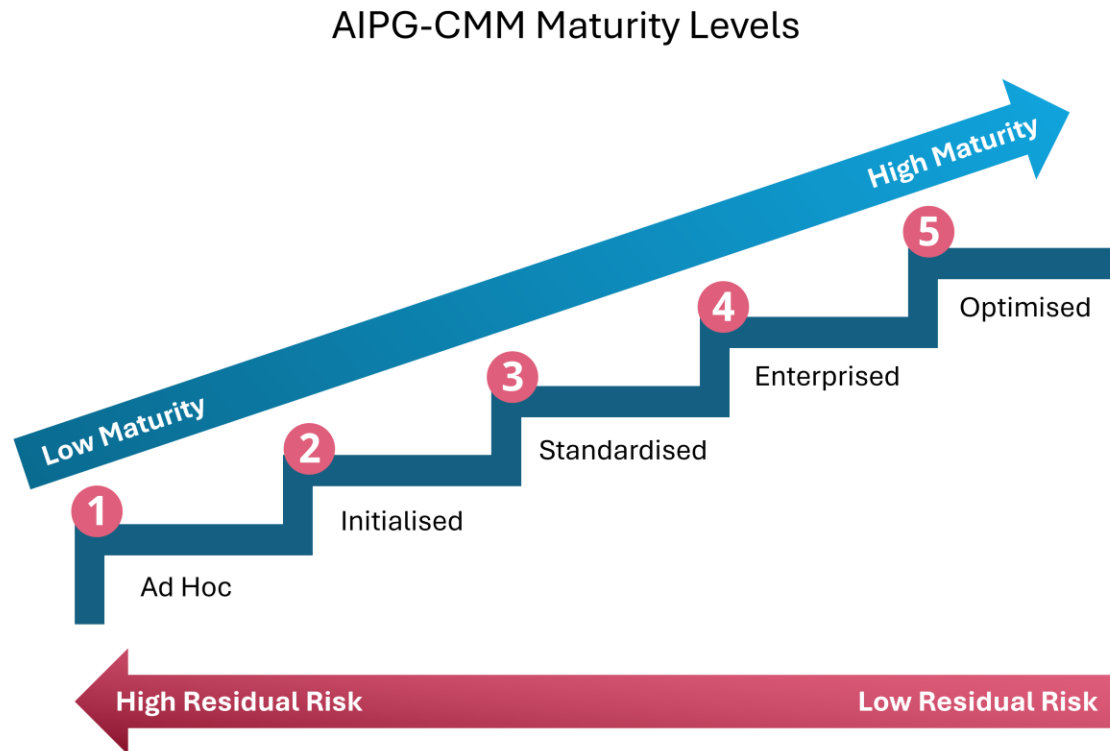
PRINCE2® and PMBOK® Mapped to AIPGF



Flexibility of the AIPGF

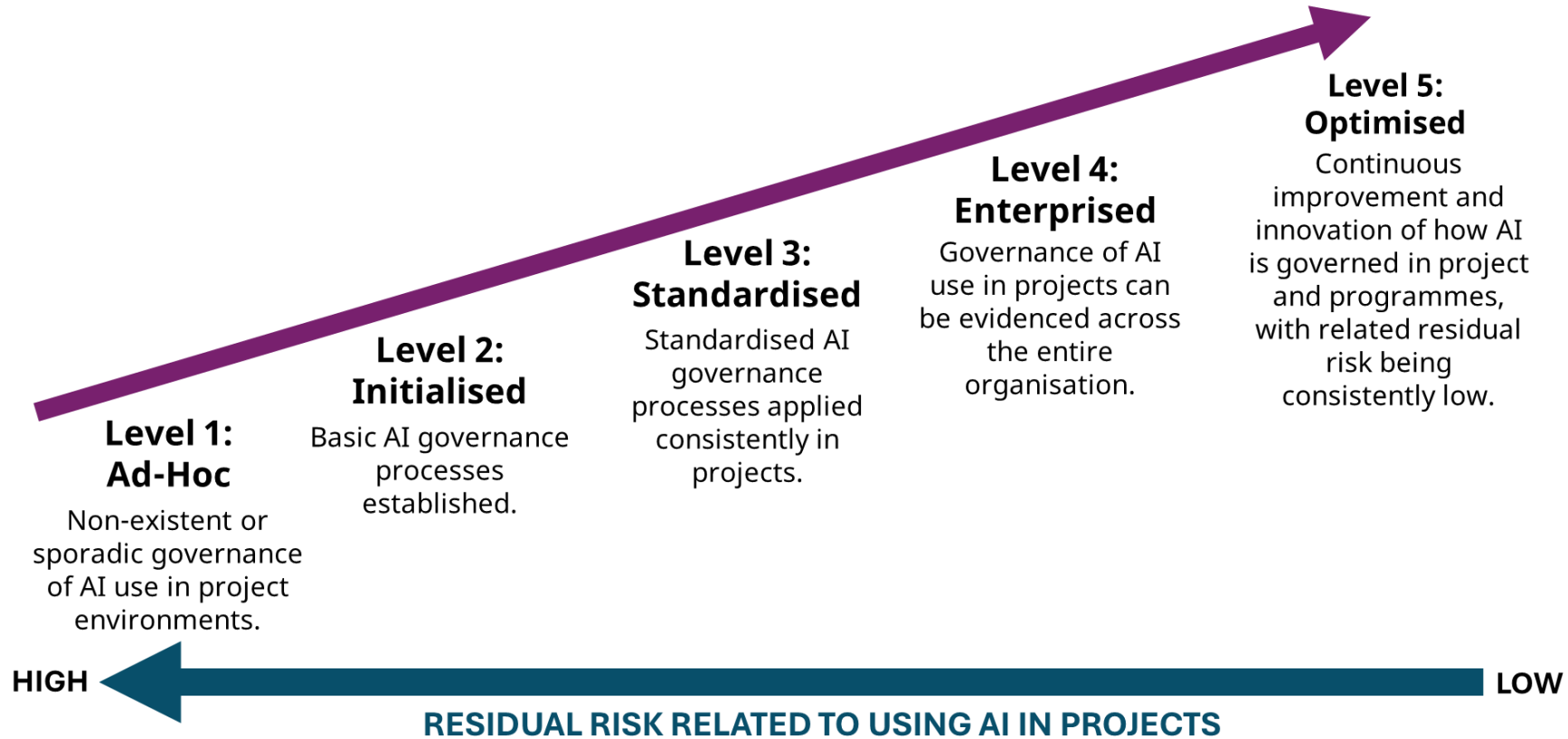

Portfolio Leaders, Strategic Programmes Office teams, Enterprise PMO Leaders, Project Sponsors and Steering Committees/Boards



Project and Programme Delivery Roles

Programme Managers, Project Managers, Change Managers, Project Coordinators, Team Members, Data Owners, Data Custodians



Governance, Assurance and Compliance Roles

Chief AI Officers, Digital Transformation Leaders, AI Ethics Advisors, Internal and External Auditors, Legal, Compliance and Regulatory Teams
